IMPORT PERMIT FOR SMALL RUMINANTS (SHEEP/GOATS) FROM ST.CROIX

This permit is issued subject to the conditions stated below. The Veterinary Authority of the BVI reserves the right to render this permit void at any time, when in its judgment, such is deemed necessary.

- 1) Permission for entry will only be granted if animal (s) is/are accompanied by an **Export Health Certificate** issued by the *Veterinary Authority of the country of origin stating:
 - a) The country of origin has been free of Foot and Mouth Disease and other Vesicular Disease, Peste Des Petits Ruminants, Rift Valley Fever, Rinderpest, Sheep Pox, Goat Pox and Blue Tongue (24 months) for the past 36 months.
 - b) That Scrapie has not existed on premises of origin during the 3 year immediately prior to shipment and that animal (s) are not the progeny of a sire or dam that was affected with Scrapie.
 - c) Animal(s) must be tested negative for **Tuberculosis**, **Heartwater** and **Bucellosis**, within 30 days prior to exportation.
 - d) Animals have been tested negatively for **Caprine Arthritis Encephalitis** or premises of origin are free of CAE.
 - e) That animal(s) are clinically healthy with no signs of infectious or contagious diseases and that there has been no reported cases of Pulmonary or Adenomatosis, Nairobi Sheep Disease, Maedi-visna or Rabies (12 months prior to shipment) in the area of origin.
 - f) That animal(s) was/were treated for Internal Parasites with appropriate pharmaceuticals.
 - g) That animal(s) was/were kept in a facility frequently visited by a veterinarian and certified to be of acceptable standards.

- 2) With Blue Tongue (BT) endemic countries, animal(s) must be kept in a quarantine station; BT free establishment for 40 days prior to the shipment and was/were subjected to diagnostic test for BT with negative results during this period.
- 3) Animal (s) must be found healthy on arrival.
- 4) ALL REQUIRED CONDITIONS MUST BE MET AND ALL RELEVENT DOCUMENTS (IMPORT PERMIT, VETERINARY HEALTH CERTIFICATE, LAB TEST RESULTS ETC). MUST BE PRESENTED AT PORT OF ENTRY, IN ORDER TO FACILITATE VETERINARY CLEARANCE.
- 5) THE VETERINARY DIVISION MUST BE GIVEN AT LEAST 24 HOURS NOTICE OF CONFIRMED ARRIVAL DATE, TIME, AIRLINE/VESSEL AND PORT OF ENTRY. THIS WILL FACILITATE UNNECESSARY DELAYS AND AVOID DETENTION OF ANIMAL (S) FOR VETERINARY CLEARANCE AT PORT OF ENTRY.
 - *An official Health certificate is a document issued and certified by a Veterinarian working full time with the government of the country of origin (e.g. USDA, Canadian Food Inspection Agency, DEFRA, etc.). The document may be filled out and signed by a licensed Veterinarian, <u>but must also be</u> endorsed by a Government Veterinarian.

Please be advised that these requirements are subject to change since animal disease status in various countries is dynamic. Therefore, the granting of permission for animals to enter the British Virgin Islands does not signify automatic entry. It is your responsibility to contact the Veterinary Division, Department of Agriculture to confirm that these conditions are current.
